Description of fees:	<p>Government Funded Tuition Fee: Student who meets the Skills First eligibility requirements and is therefore eligible for a government subsidised training place</p> <p>Government Funded Concession Tuition Fee: <i>Note: as per the Skills First Contract, Fee concessions only apply to programs at Certificate IV and below.</i> To be eligible for the concession rate you must be eligible for a Skill First government subsidised training place and at course commencement, you must hold a current and valid: Commonwealth Health Care Card, Pensioner Concession Card or a Veteran's Gold Card.</p> <p>Fee for Service (Non funded course fee) Fee for service rates apply to those applicants who do not meet the Skills First eligibility requirements.</p>
